1) Why would you like to serve on the Board of Directors of the North Coast Cooperative?

Since a cooperative exists to serve its members and follows cooperative principles, I would be honored to assist with the continuing success of the North Coast Co-op by offering my services.

2) Describe how your experience, including education, training and working with other groups or boards, will help you succeed as a board member.

My educational background is in Education and Nutrition, with degrees from The Ohio State University and University of Central Arkansas. I worked for the State of Arkansas, taught elementary school in the Little Rock School District, and then pursued a degree in Dietetics and Nutrition before moving to California in 2002. I began work in the natural foods industry in the late 1990s. First in an independent natural foods store in Little Rock, AR, then for a national chain as a Regional Marketing & Demo Coordinator for 11 stores in the lower Midwest. Lastly I worked as the Consumer Education Coordinator in the Marketing Department at the North Coast Co-op 13 years. My first assignment at North Coast Co-op was to get our local farmers and food producers excited about participating in the Co-op's 30th Anniversary Party. Since I was new to Humboldt, reaching out to the farmers and producers provided a way to get to know about the abundance of truly amazing local produce and products we have. While I was a Co-op employee and since my retirement from the Co-op in 2016, I have attended many BOD meetings. I have received the board packet and other meeting notices by email since 2017 and enjoy keeping up with what is happening at the Co-op. I am a regular shopper at the Co-op and I'm familiar with many Co-op employees.

3) What do you see as the most important opportunities or challenges facing the Co-op in the coming five to ten years?

In this time of increased costs of goods, I feel that keeping prices as low as possible is a challenge. Co-op shoppers have increased living expenses and less cash available for basic needs. Keeping business costs in check and monitoring margins will be extremely important. Continuing the Co-op's sustainability efforts and educating members about them will continue to promote changes in lifestyles that benefit not only the Co-op but our entire community. Shopping with durables and promoting the use of less plastic. Attracting families and young people to our Co-op should continue to be a focus, perhaps with events at the stores. A "Back to School Extravaganza" with sampling of snacks and kids' lunch options and supplies, is an example.

4) Please share additional thoughts you would like the membership to know.

I currently work for Area 1 on Aging as a Health Insurance Counseling and Advocacy Program (HICAP) counselor. I am a detail-oriented person, and this job makes use of that skill. As a member of the Co-op's BOD, I would pay attention to details as presented in the Board Packet each month.

1) Why would you like to serve on the Board of Directors of the North Coast Cooperative?

I am currently serving my first term as an Employee Director and have been the Treasurer for the past year and half. I have strived to increase my understanding of how our finances work, how to read financial documents, as well as communicate that information to coop staff, members and new board members. I believe I have helped rebuild a better working relationship and increased trust among the Board, members and staff, and I hope to continue that work.

2) Describe how your experience, including education, training and working with other groups or boards, will help you succeed as a board member.

As I mentioned above, I have served on the board for the past two and half years. Prior to that, I had attended Board and Board Finance Committee meetings for a year prior to being elected. That experience, along with my good working relationships with the Co-op General Manager, Sean and the Co-op Controller, Barney, and other Board members make me a useful member of the board. As head of the wine and spirits department at the Arcata store and head of the beer and wine department at the Eureka store, I work in both locations, giving me a broader perspective on the workings of the total Co-op. This also makes me available to a broader group of Co-op employees, members and customers as a Board member to receive feedback and explain board actions and responsibilities.

3) What do you see as the most important opportunities or challenges facing the Co-op in the coming five to ten years?

Humboldt county's residents and economy are in the midst of a large transition. In the past couple of years the population in Arcata and Eureka has shifted, new businesses are moving into the area, such as the aquaculture farm on the Samoa Peninsula and Google's transpacific cable, and the transformation of Humboldt State University into Cal Poly Humboldt will all impact the community, its residents, the economy and consequently the Co-op. Guiding the Co-op through these changes in a way that ensures the robustness of the Co-op's triple bottom line - people, planet, profit - is what I see as the most important challenge and opportunity in the coming years.

4) Please share additional thoughts you would like the membership to know.

I believe I have been a useful member of the Board and I wish to continue that work. While three years may seem like a long or short time, depending on the context and perspective, I feel as if I am just getting started in making a positive impact on the culture of the board and its interactions with staff and our members. I hope to continue to do this important work.

Voting Guidelines

Members can cast their ballots from September 20 through October 19 at 9pm.

Votes will be considered valid if all of the following apply:

1. Membership with North Coast Co-op is current as of August 6, 2022. Household Shoppers on a membership do not qualify to vote. To check your membership status, contact membership@northcoast.coop or (707) 443-6027 x 434.
2. Votes per ballot cannot exceed the number of open seats. There are two open seats.
3. There is one open Employee Director seat that must be ratified by the membership.
4. Ballots must include the member's name written legibly, their membership number and their signature.
5. Write-in candidates must be current members of North Coast Co-op and agree to candidate requirements (list available at voting table).
6. All ballots, including mailed ballots, are to be received by 9pm on October 19.

Policies and Procedures

- A vote may be cast online (preferred) or with a paper ballot.
- In the event that more than one otherwise valid ballot is cast by the same membership but by a different name on the membership, the vote of the majority will bind all.
- Electioneering will not be allowed within 15 feet of the ballot boxes or 5 feet of any entrances to the stores.
- Ballot boxes are located near the front entrance in each store.
- Ballots may be dropped off at ballot boxes in the Arcata or Eureka store or mailed to the address shown on the ballot. All mailed ballots must be received by 9pm on October 19.
- For a vote to be valid a quorum must be met, which is 250 or 5 percent of the membership (whichever is lesser) casting valid ballots.
- The two candidates receiving the highest number of votes will be elected.
- The Nominating Committee will count the ballots on October 22 and notify the membership with in-store signs by Wednesday, October 26.

Online Voting Guidelines


- Online voting can be accessed through a web browser on a computer or mobile device.
- The member number, full name and signature prompts are required for a ballot to be valid.
- All voting prompts are optional. You may answer as many as you want to.
- Refreshing your browser window will restart the voting process. Only do so if you intend to start over.

- Step 1 Go to www.northcoast.coop/vote on a computer, tablet or mobile device.
- Step 2 The front page has information on how to access this Election Guide electronically and the ballot submission deadline. Select START to proceed to the first question.
- Step 3 Enter your member number. This is a required step. Select NEXT to proceed to the next question.
- Step 4 Enter your First and Last name. This is a required step. Select NEXT to proceed to the next question.
- Step 5 You may choose up to two candidates to vote for from the selection (including write-in candidates). You may choose up to two write-in candidates as your choices by selecting any of the write-in options. (You will be prompted to enter write-in candidate names on the following page) Select NEXT to proceed to the next question. (If you choose not to vote on this question, select NEXT to continue to the next question.)
- Step 6 You may choose up to affirm or reject the candidate elected by employee members during the employee election. Select NEXT to proceed to the next page. (If you choose not to vote on this question, select NEXT to continue to the next page.)
- Step 7 Draw your signature in the designated box. If you are on a computer, use your mouse or trackpad to draw your signature. If you are on a touchscreen device, use your finger or stylus to draw your signature. You may select the CLEAR button to remove the signature if you need to start over. This is a required step. Select SUBMIT to complete the voting process.

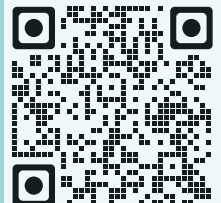
