#### 1. Welcome

Meeting was called to order at 6:01pm by Colin.

## 2. Agenda Review and Approval

Move member comment period in front of the consent calendar.

Consensus to approve the agenda as amended.

#### 3. Member Comment Period

Roger – reports that his solar company encourages the companies he orders product from to reduce their plastic and it appears to be working. He encourages other businesses to do the same. He is still upset about the prepackaged Los Bagels.

o Kiya – the Co-op has a letter that we send to vendors to encourage them to decrease their packing.

### 5. Board President Report - Reported by Colin

## a) Strategic Planning Update

A draft plan is scheduled to be presented at the July 5 board meeting. Our hope is that the final document will be adopted at the October 21 Annual Membership Meeting.

#### b) Board Correspondence

Colin has been in contact with previous correspondents regarding protein powder and raw milk. There is nothing new to report on these items.

Humboldt Area Center for Harm Reduction (HACHR)

Rachel Waldman (HACHR Board Member) – several organizations have received floods of emails like those the Co-op recently received. The funding from the Cooperative Community Fund (CCF) helped us upgrade our kitchen and it's been extremely helpful. We were even able to hire another staff member to help in the kitchen. We thank CCF and the Co-op for granting us the funds to assist our kitchen.

- Cheri and Mary Ella don't see need for further conversation with those that had written to the Co-op beyond Colin's initial response.

- James if we receive further contact I suggest responding that the board fully supports the grant to HACHR.
- The board agrees with James and thanks Rachel for attending the meeting.

## 6. AB 2909 – Reported by Leah

- Colin – remove asking Jim Wood to support the bill and instead thank him for authoring it.

**Motion:** Authorize Leah to send the AB 2909 support letter on behalf of the board as amended.

Approved by consensus.

## 7. How to Strategically Develop New Projects - Reported Colin

This agenda item comes from a session I attended at the CA Co-op Conference where I learned that it's potentially dangerous to start a project at a site that is predetermined versus determining the scope of a project and then determining the location. I want our Co-op to be proactive versus reactive in development projects.

- Leah we also learned that there are exceptions such as if the developer was particularly invested in your project or if you are the keystone partner.
- James pro forma and markets study times need to be quicker to analyze if a project is worthy.
- Melanie having a clear growth plan is needed. We need to identify our grown needs and wants.
- James would like to ask the membership more questions about what type of growth they want.
- Mary Ella we need to keep in mind that the future will not be like the present and we need to plan with that in mind. We should have a plan to survive the next big recession.

## 8. Online Shopping & Delivery Option – Reported by Colin

Peoples habits of shopping are changing. It could change rapidly. I'd like to figure out a way to interact with people in a way that doesn't just rely on them coming to the store to make their purchases. The Member Action Committee had been brainstorming ideas, such as connecting members that can help deliver food to other members, paid delivery services, and making the stores into more of a community space where people come for social reasons, not just to purchase their food.

- Kiya it's a good opportunity to focus on Co-op branded items and Co-op Basics for home delivery.
  - o Evan You'd need a refrigerated vehicle if delivering perishable items.
- James "Uber Eats" does food deliveries in cities. I like the idea of delivering food to members as an additional member benefit.
- Jason getting an online shop up and running is easy. A clearly defined scope and outcome is critical for the technical side of things. Delivery is where it gets tricky. It's all doable if we have exact goals.
- Colin likes the idea of taking a diverse approach building a community-based delivery system.
- Melanie all of these ideas require resources, re-education and time. What do we want to focus our energy on? Building a community space at stores or delivering food to people?
  - O Colin wants to make sure we are responding to trends in the grocery industry to remain profitable.
  - James tonight was an act of engaging enthusiasm about a specific topic. It would be nice to have a list of goals, rank them, and then have staff investigate the top ideas.
- Robert are there any stores in Trinity, Humboldt, Mendocino or Del Norte offering online shopping?
  - o Melanie not that I'm aware of.
- Melanie we were planning to implement online ordering for the Eureka deli remodel. It could be a good test to see how many people use it versus continue to order in store?
- Colin likes the ideas of member to member delivery and the Arcata parking lot redesign that includes added community space. I'd like to work on both. People will want both.
  - o Evan please take into consideration that squatters will take advantage of public spaces and to plan accordingly when designing new social spaces.
  - O Kiya monitoring of public spaces must be consistent. We need to manage for bad behavior.

#### 9. Earth Action Committee (EAC) – Reported by Leah

There was discussion around encouraging and emphasizing cooperative and environmental values in job postings, interviews and orientation.

- Melanie this is happening. It's part of orientation, is included in the interview, job descriptions and the recently updated employee handbook. A lot has been done by management to change the culture.
- Kiya would like to do more fun employee giveaways that give out durable containers.
- Cheri sees employees taking coffee cups from the floor, upstairs to get breakroom coffee. Also stacks of coffee cups have been brought upstairs.
  - o Melanie if you see stacks of paper cups upstairs, inform management. It is not okay for employees to take paper cups.

James moved,  $2^{nd}$  from Robert, Motion passes (7/0/0).

### **10.** General Managers Report – Reported by Melanie

- Colin what is the condition of the equipment being salvaged from Safeway stores?
  - o Melanie CRS is removing them and evaluating them. They are not old and should be energy efficient.
- James can we see how our expenses are doing to budget in the finance report?
  - Melanie yes, we just don't have the April financials yet.
- Colin can you talk about the needle disposal box proposal?
  - o Melanie it would be a small box mounted on the outside of the building in Eureka. The needles get removed by HACHR once a week, or more, as needed.
  - o Laurie researching the boxes, including messaging to shoppers and employees.
  - O Melanie we are checking with our insurance company to make sure it wouldn't increase our liability. Staff would need to know about it and be educated not to pick up any needles.
- Colin has the Eureka roof leak been found?
  - o Melanie yes, they know the source and that its shorted out the lights in the atrium area. The atrium lights will remain off until it is fixed.
- Colin what is happening with the Co-op Access Program?
  - Laurie final surveys are coming back now. The program will be reviewed by staff in June with an initial proposal presented to Member Action Committee in July.
- James are there any updates on health plans?
  - Melanie we signed on with a new broker and are moving forward. We recently met and reviewed our plans with the Union Representative, Shop Stewards and new broker. We are waiting for comparison of providers and prescriptions before signing a contract. We extended our Humboldt IPA through August.
  - Cheri Michelle did a great job with her presentation to the Union Representatives and Shop Stewards.

Motion: Accept the June 2018 General Manager Report.

James moved,  $2^{nd}$  from Leah, Motion passes (7/0/0).

#### 11. Member Comment Period

- Evan I heard a lot of talk tonight about ideas and strategic planning but didn't hear anyone talk about adding value to the customers experience. Value is the most important thing. Your decision-making process is slow, and it puts you behind your competitors.
- Lisa supports the needle drop-off. However, there could be a big backlash, especially from parents. Be very careful how you message it.
- Lauren I would like there to be options for the community to dispose of needles.
