#### 1. Welcomes and Review

## **5.** Energy Planning – Reported by Travis

Roger commented about an old condenser unit on the Arcata roof that could be removed to make room for more solar.

- As part of a PG&E program, we are working on replacing old lights with more energy efficient lights. PG&E will cover most of the cost of the bulbs.
- Refrigerator door sealants will soon be replaced in Eureka to conserver more energy.
- Looks as though we are using the same amount of energy currently as we were last year.
- Signed up for a \$100,000 loan for both locations at zero percent interest.
- Still working on addressing concerns with Mission Linen.

### **6. Co-op Vehicles** – Reported by Travis

- The transit van (mail/food/general transport needs) is off the depreciation list, doing ~700 miles/month in good condition.
- The cargo van (used by maintenance) is doing ~200 miles/month with over 200,000 miles.
- The box truck (warehouse deliveries) has ~100,000 miles and is in good condition.
- All three are well maintained and should make it through the year fine.

Laurie – mentioned having a Co-op vehicle for staff to use in the future.

#### 7. Transportation Survey – Reported by Laurie

Looking to do the survey in mid-May, the first week of June and then in September when the students are back.

Colin – is it possible to capture mixed mode trips (i.e. one or more of the above)? Did you come to the Coop as a single purpose trip or multi-purpose?

The group discussed what information might be capture since the survey will be done in person.

Cheri is concerned that employees are no longer expected to use their own food containers or pay for Co-op containers. It used to be part of the culture and it's no longer being followed. The group discussed ways to discourage shoppers and employees from using disposables.

- It would be good to include education about reusables in employee orientation.
- We should buy more thrift shop mugs/silverware for breakrooms.
- What if you only get a coffee card punch if you have your own mug?
- Maybe only members should get coffee/sandwich punch cards.
