1. Welcome: At 5:30pm Jules welcomed everyone, and introductions were made.

2. Approve Minutes

3. Member Comments

- Steve in the current Co-op News there was mention of the upcoming strategic planning process. Steve sees a lot of emphasis on running a store and not as much on community building. Steve would like to be part of the strategic planning process around the idea of real community and real food. How do we engage people who shop at the Co-op to be part of a community?
 - O Colin Challenge is to integrate the operational and community aspects via the strategic plan. The stores are the hub of what creates community.
- Steve Locally Delicious kick-off on Feb. 23. They would like the Co-op to help sponsor this kick-off.

4. Purchasing Policy

- Emily the policy has been posted in both stores on the board boards and online.
- Laurie maybe we need a better area for posting educational materials.
- Colin envisioning a poster of the policy. Could it be on an easel that gets moved around?
- Laurie Customers are not likely to read the entire policy during a shopping trip. Could we boil the policy down to a few sentences that cover the basics of it?
 - Colin agrees with Laurie that we could summarize the policy.
 i.e. It is the Co-ops goal to sell items that are environmentally sound, socially responsible, local, and meet member needs.

5. Annual Membership Meeting

At the January board meeting Roger proposed closing both stores on the day of the Annual Membership Meeting (AMM) so that all member employees could attend.

- Jules not sure how many employees would actually attend. Many have the day off and don't attend.
- Laurie \sim 75% of employees are members.
- Cheri I don't think the store needs to close. Those that want to go can ask for the time off. Shoppers are upset when stores close at unusual times.
- Laurie if we want to encourage employees to go we should give advance warning to request time off or switch shifts.
- Colin AMM attendance largely depends on what is happening at the AMM. Maybe the MAC needs to start focusing more on ways to grow member involvement in general. How can we make the AMM more

meaningful, to make it important enough to close the stores? Or are there better ways to get members involved?

- Laurie if we get members involved in other ways they will more likely attend the AMM.
- Jules proposes allocating 20-30 minutes towards member engagement at the next MAC meeting.

In the past MAC has come up with member questions for the Co-op News. The next issue will likely have a question pertaining to strategic planning. The committee would like to dedicate a half page in the next Co-op News based on strategic plan related questions.
