### **Alexandra Profant**

1) Why would you like to serve on the Board of Directors of the North Coast Cooperative? I would like to serve on the Board of Directors to continue to learn about, and help fine tune the "gears" which make the North Coast Co-op run smoothly and persist to "function."

As a member, who joined when the Co-Op when my child was a toddler, whose presence was welcomed by the-then, tiny Eureka store, as well as being a former board member who served on the Board, and, as a local vendor of private forestland family farmed wood products (and, up-cycled products made in part, from collected recycled items, at our two stores) to, the co-op/ members & customers, as of 2022/2023 -has given me a unique vantage point to recognize continuity hiccups between the two stores, (Eureka & Arcata), yet, a singular entity.

This knowledge and experience informs my current desire to share my time, by serving the membership, employees, and broader Northcoast Co-Op community, again, as an elected board member.

### 2) Describe how your experience, including education, training and working with other groups or boards, will help you succeed as a board member.

I am a co-founder and director, of a 501 (c) 3, where said charity, with slow, steady, grass-roots growth, has caused focus and strength, in our mission, enduring over the years, with little monetization. There is a widening gap between those who embrace emerging technology as the be-all/end-all-answer to everything, and to those who rely on traditional "old-school" ways of doing things;this is cause for me to run for the 2024 electionto be a viva voce voice for those of us who still rely on snail mail, walk-in person-to person business activity, and paper ballots with humans counting them. # **Voting Guidelines**

### Members can cast their ballots from September 18 through October 16 at 9pm.

### Votes will be considered valid if all of the following apply:

- 1. Membership with North Coast Co-op is current as of August 4, 2024. Household Shoppers on a membership do not qualify to vote. To check your membership status, contact membership@ northcoast.coop or (707) 443-6027 x 434.
- 2. Votes per ballot cannot exceed the number of open seats. There are two open General Director seats.
- 3. Ballots must include the member's name written legibly, their membership number and their signature.
- 4. Write-in candidate must be current members of North Coast Co-op and agree to candidate requirements (list available at voting table).
- 5. All ballots, including mailed ballots, must be received by 9pm on October 16.

### **Policies and Procedures**

- A vote may be cast online (preferred) <u>or</u> with a paper ballot.
- In the event that more than one otherwise valid ballot is cast by the same membership but by a different name on the membership, the vote of the majority will bind all.
- Electioneering will not be allowed within 15 feet of the ballot boxes or 5 feet of any entrances to the stores.
- Ballot boxes are located near the front entrance in each store.
- Ballots may be dropped off at ballot boxes in the Arcata or Eureka store or mailed to the address shown on the ballot. All mailed ballots must be received by 9pm on October 16.
- For a vote to be valid a quorum must be met, which is 250 or 5 percent of the membership (whichever is lesser) casting valid ballots.
- The two candidates receiving the highest number of votes will be elected.
- The Nominating Committee will count the ballots on October 19 and notify the membership with in-store signs by Thursday, October 24.

### **Online Voting Guidelines**

- Online voting can be accessed through a web browser on a computer or mobile device by visiting northcoast.coop/vote.
- The member number, full name and signature prompts are required for a ballot to be valid.
- All voting prompts are optional. You may answer as many as you want to.
- Refreshing your browser window will restart the voting process. (Only do so if you intend to start over.)
- Refer to this election guide during the online voting process, if needed.


