1. Welcome

The meeting was called to order at 6:04 by Kirsten and introductions were made.

4. Member Comment Period

- Roger Nezzie from AHHA communicated with me about the Co-op wanting Seeds for Change organizations to donate prize for encouragement to cashiers. She was concerned about what happens to organizations that can't afford to make prize donations?
 - Emily I do encourage all organizations to donate prizes for cashiers as a way to encourage them to
 ask customers to round up. As far as organizations being able to afford to do so, I feel like when we
 can guarantee that each organization is going to make a minimum of \$8,000, that they can afford to
 make a small donation of prizes and consider that donation a fundraising expense. Additionally, the
 Co-op does have its own ways of helping to encourage cashiers to participate in asking customers to
 round up.
- Roger Jody Ellis noticed staff get a large discount, but members don't.
- Roger Co-op basics there is a peanut butter in plastic and one in glass. The one in plastic is cheaper. I would like to see if it's possible to work with vendors or pricing to make the glass jar cheaper than the plastic jar.
- Kirsten I was really impressed by the hot bar in Arcata Thanksgiving week.
- Mike I heard that the Co-op recently was very accommodating to hire someone with occupational challenges and I was really impressed by that.

5. Board Correspondence

- Kirsten the board received an email from Holly Sage about Eureka Natural Foods promoting a sale of 25% everything in their store for two days and wanted to know how that impacts the Co-op.
 - Roger yes, I think it will impact the store. That's how sales work. And when the Co-op has a sale it impacts other stores.
- Alex Is the current board interested in providing a communication to members to include in the Co-op News. It doesn't have to only be about what happens at the board meetings, but can include general things that are happening with the Co-op.
 - Kirsten I plan to write something that I will email to staff and could be included with the Newsletter.

- Alex we've been discussing ways to get more people to board meetings. Why should members attend board meetings? What's in it for them?
 - Mike if members were attending, they might be more interested in running for the board.
 - Kirsten I would like to invite our Business Partners to attend Board meetings. I would like to
 highlight businesses that shop at the Co-op. Not necessarily Business Partners, but highlighting local
 businesses and why they choose to shop at the Co-op.
 - Mike we've been discussing the past 50 years, but I'm also interested in discussing the next 50 years.

Renovations are complete in Arcata, excluding baseboards. Eureka production flooring is scheduled to be done in January. Customers are enjoying the updates.
