4. Onsite Composter/Digester

The composter is officially in transit and should arrive around March 17.

Kiya is finishing up the plan for customers to be able to purchase a compost stamp card and get a compost bucket to join the Co-op compost program to be able to drop off home compost at the Co-op.

The committee agrees they want to see used buckets be upcycled for the compost program.

5. CRV

The Co-op received its first out of compliance CRV bill will charges the Co-op a fee of \$100/day. We never received a response from the emergency letter that was sent to the CA Governor and CalRecycle to allow local CRV centers to be recertified. Kiya will continue communication with the local CRV working group and report back.

6. Tesla Battery Update

The Co-op is receiving a large Tesla battery via a CA grant program. The battery should take demand off the grid during peak times and will save the Co-op money on its electric bill. It will also serve as a power source when the power is out. The Eureka store will be closed on March 20 for the initial install of the battery.
