# December Board Meeting Recap

The board will issue a patronage refund of \$337,465 for Fiscal Year 2016. Fair Share members will receive their refund in 100% cash. All others will receive 50% cash and 50% in B Shares, except where

the cash contribution is less than \$2. Any cash distribution less than \$2 will be issued in B Shares.

It was announced that former Board President Dave Feral will be unable to finish out his term. The board plans to make an appointment to fill the vacated seat at the February board meeting. If you are interested in serving on the North Coast Co-op Board of Directors, please submit a letter of interest to Membership Coordinator Nicole Chase or leave it at either of the Customer Service counters. At the February board meeting we will have a brief candidates' forum and will appoint the new board member to begin in March. We invite all interested in this process to attend the February board meeting on February 2, 2017, at 6:00pm at the Ten Pin

Building in Arcata.

It was voted that the two percent dividend on C shares will continue for the next quarter. The first ever co-op member-only coupon was placed in the December *Senior News*; it was a coupon for 10% off on a shopping trip.

The board accepted the audit report. All General Manager expenses and disbursements will be approved by either the Treasurer or the Board President prior to Finance Committee meetings each quarter.

Staff was directed to develop an index of indicators to measure ecological impact of the proposed Eureka deli remodel. In preparation for the Eureka deli expansion and reset, three non-bargaining unit positions have been created.

# Zero Waste Business Council

We at North Coast Co-op take our environmental responsibility very seriously, and we know our members do, too. Though we felt we were doing a lot to reduce our environmental impact, we decided to send members of our maintenance team to a Zero Waste Business Council (ZWBC)

score card training seminar to better evaluate our efforts. Our maintenance team learned what guidelines the ZWBC uses to determine what businesses can be certified as a zero waste business. The ZWBC aspires for 100% diversion from landfills and burning, but also certifies businesses that can achieve a 90% diversion rate at their lowest certification level.

Our team determined that we are already doing approximately 87% waste stream reduction through various partnerships and in-house programs. We divert all of our produce waste and spoilage either through donation to Food for People, or to local farmers for animal feed. We divert all of our compostable material to The Local Worm Guy. We have an in-house single stream recycling program staffed by our maintenance team, and

we reuse all of our pallets through various vendor partnerships. Many of our local vendors deliver to us in reusable containers which we then return to them upon their next delivery, further reducing our local waste stream.

We are currently looking at the pros and cons to getting certified as a zero waste business. The certification costs vary depending on the size of the business and could cost us a few thousand dollars per year as you have to get recertified each year. If we do move forward with certification, we will get some minimal national advertisement from doing so. We would also be supporting the Zero Waste Movement, and help it gain momentum. We would appreciate any members’ input; please feel free to put your opinion in our comment

boxes at either of our locations, or answer the survey question below! Either way, we endeavor to achieve 100% waste diversion and need your help to achieve it.

Our team has come up with new inventive ways to further reduce our waste stream since attending the training. They are also looking to create new local partnerships to help reduce our local waste stream. Our team has learned of opportunities to turn our waste into local dollars that would come into our community from various localities that have the infrastructure to make “waste” a commodity. As we move forward into the future, we move with purpose. As the Zero Waste Business Council says, “If you aren’t for zero waste how much waste are you for?”

## Steamed Winter Leeks

Leeks are relatives of the garlic, onion, shallots and scallions family, Allium vegetables. Packed with generous amounts of Vitamin A and Vitamin K, they have a more delicate and sweeter flavor than onions and make a great addition to vegetable-based dishes. When purchasing leeks, they should be firm and straight with dark green leaves and white necks. Look for leeks throughout the year, although they are in greater supply from the fall through the early part of spring.

Rinsing is very important for leeks, as soil is often trapped between the many layers of leaves. Start by trimming off the base and cutting away the uppermost part of the leaves. To keep the leek whole, use a knife to make a slit from the top to the point where the green meets the white, cutting through the center. Rinse well under running water, pulling back the layers so that any dirt at the base is removed.



## COOK & SAVE

### Ingredients:

- 2 medium leeks
- 1 Tablespoon olive oil
- ½ Tablespoon stone ground mustard
- 1 teaspoon Dijon mustard
- 1 teaspoon white wine vinegar
- Salt and pepper to taste

### Directions:

1. Trim dark green leaves from leeks (toss them in the freezer for stock making) and halve leeks lengthwise.
2. Simmer a large saucepan of water to steaming and cover with steamer basket.
3. Prepare ice water.
4. Add cleaned leeks to steamer basket, cut side down and steam



5. until very tender, about 10 minutes.
5. Prepare dressing, whisk mustards, vinegar and oil and season with salt and pepper to taste.
6. Transfer done leeks to ice water and cool 1-3 minutes then drain.
7. Pat dry with a clean kitchen towel.
8. Spoon dressing over leeks and serve.

# Qtr 2, Fiscal Year 2017 Financial Report

The second quarter of the financial year closed on September 24, 2016. Our combined year-to-date sales are 4% better than our projected budget and both stores are showing growth compared to last year. For Q2, the Arcata store is seeing an increase in sales, year over year, of \$129,570 or 2.5% better than last year, and the Eureka store is up \$101,506 or 3.0% over last year—all this while keeping purchases and

expenses in line. We have had good customer counts and strong basket sizes in each store so far this year and the sales are showing it.

The year-end audit for fiscal year 2016 has been completed. At their November 29 meeting, the board of directors accepted the audit findings. The audit was clean, with a few suggestions for improved systems and accountability.

We have started working on our budget for fiscal year 2018. Using the principles of Open Book Management, the process involves each department preparing their

own budget to add to the overall budget. While this can be time consuming for all involved, we end up with a much more accurate budget. We will continue working toward a final document to present to the board of directors for approval in February of 2017.

Even with new competition in McKinleyville—Eureka Natural Foods opened in August—the first two quarters have been good for the Co-op. We look forward to exceeding expectations in the next quarter as well!


