## 4. Candidate Qualifications

The committee reviewed current qualifications and discussed additional qualifications to consider adding to the Board Policy Manual.

Must be 21 years of age.
Currently you must be 18 years of age. The question arose that board officers are on the Co-ops ABC license and whether or not someone under the age of 21 could then be an officer.
ACTION - Kirsten will talk to ABC to find out the legalities of this.
Must have attended a minimum of 1 board meeting within (insert time frame).

- We don't want to make it harder to run for the board.
- What if the election timeframe and time of which you start to serve on the board were separated by a month, so newly elected candidates could attend one meeting before starting their new term?
AGREEMENT: Discuss further at the next PPC meeting, along with the election timeline.
No person may serve as a director if that person's service as a director would result in two or more related persons being directors at any one time. The term "related person" means the spouse, child, grandchild, sibling or parent of the person, domestic partner and any individual sharing the household of the person.
- The committee likes defining the term "related person" to be included in the Board Policy Manual.

AGREEMENT: To be discussed again at the March Nominating Committee meeting.
