

# Policies & Procedures Committee Meeting Minutes – July 15, 2020 ZOOM Call

- 1. Welcome/Introductions/Agenda review and additions Meeting commenced at 6:03pm. Laura welcomed everyone, and introductions were made.
- **2. Approval of minutes** May minutes were approved by consensus.

## 5. Board Qualifications – reported by Laura

Discussed at what time a person is deemed a candidate.

**Recommend to the Board:** Add the following definition of a candidate to Section 5G of the Board Policy Manual. "A member is deemed a candidate upon the approval of their application to run for the board by the Nominating Committee or Board of Directors."

Motion passed by consensus.

#### 6. Annual Member Fee

The committee discussed the annual member fee proposal that was brought to the last PPC meeting by staff. Any fee proposal would have to be approved by the membership. Overall, the committee agrees with the staff recommendation and additionally likes the following changes:

- Start with a \$10 annual fee.
- Allow a grace period to pay the fee prior to expulsion.
- The amount the fee can increase year to year needs to be defined.

# 7. Supporting/Spinning Off Other Co-ops - reported by Colin

One of the cooperative principles is supporting other co-ops. We have nothing official in our policies that calls out what we are doing to live up to the principles of supporting Co-ops.

- Could a percent of non-patronage earnings could go to invest in other co-ops?
- We could reach out to the California Center for Cooperative Development to see what they recommend for policies/actions that we can take to promote the cooperative economy on the north coast.
- We can invest in other co-ops which stays on our balance sheets or spend money on other co-ops to assist in their development.
- We could adopt a policy among suppliers about prioritizing doing business with co-ops. This could go into the Purchasing Policy.

#### 8. Employee Directors – reported by Roger

At the last PPC meeting the legalities around increasing the number of employee board members came up. The primary issue is potentially union negotiations.

- Discussed that the more employees allowed on the board the closer it brings the Co-op to being a worker owned cooperative, which it is not.
- If employees need more representation, then the logical step would be to become a worker co-op.
