5. Members Entitlement to Vote Policy Update – reported by Colin

The group discussed changes to bylaws section 4.13(c) to clarify the member eligibility to vote by date for Co-op elections.

Proposed Changes to Bylaws Section 4.13(c)

The record date for determining the members entitled to vote at a meeting or east written ballots is forty-five (45) days before the date of the meeting. The record date for determining the members entitled to vote via written ballot without a meeting is forty-five (45) days before the start of voting.

Recommend to the Board:

Adopt the bylaws change subject to review of the board attorney and place on the election ballot if necessary. Authorize Leah to consult with the attorney.

Annual proportion of old products assessed against purchasing policy	5%
Annual change in customer/employee trips using active transportation or transit	+5%
